In our opinion and to the best of our information and according to the examinations carried out by us and explanations furnished to us by the Company, its officers and agents, we certify that:

- A. The Annual Return states the facts as at the close of the aforesaid financial year correctly and adequately.
- B. during the aforesaid financial year the Company has complied with provisions of the Act & Rules made there under in respect of:

 3.  4.  5. During the year under review, the Company has closed its Register of Members from 17th September, 2021 to 23rd September, 2021 (Both Days Inclusive) for the purpose of Annual General Meeting.





6. The Company has not given any advances/loans to its directors and/or persons or firms or companies referred in section 185 of the Act. However Company has given/extended Corporate Guarantee to its subsidiary Company in which Company is holding 98.45%.
7. As informed by the Management, all the contracts/arrangements made with related parties as specified in section 188 of the Act are at arms' length and approved omnibus by Audit Committee which are of repetitive nature and approved by the board at the meeting of Board of Directors and taken approval of the Members of the Company for material transaction.
8. The Company has not issued or allotted or bought back any securities during the period under scrutiny. Transfer/transmission securities are carried out by the Registrar and Share transfer agent of the Company in due compliance with the Act.
9. There is no need of keeping in abeyance the rights to dividend, rights shares and bonus shares pending registration of transfer of shares.
10. The Company has not declared dividend during the year under review. The Company is not required to transfer any amount to the Investor Education and Protection Fund in accordance with section 125 of the Act during the year under review.
